An Option for Support Not Often Thought Of

How does a staff of four build five homes a year all over the Iron Range? By bringing our communities together, of course! Without you we would not succeed. There are many ways to support Habitat. For some it's volunteering on a construction site or committee. Others use their skills in the kitchen and help feed hungry construction volunteers. Many choose to donate funds knowing their dollars will be well spent to build homes. There are a great number of our partners who do more than one thing, donating their talents and their treasure to help us help families in need with a hand UP. We are very grateful for each of you and for all the ways you support the building of homes with our neighbors in need.

Planned Giving is a way to support Habitat's mission that is not often thought of. Many of us do not think of planned giving as something we could do, to some it may be an entirely new concept. When we do think of Planned Giving we generally think that leaving a bequest is an option for people with very large estates. This is not the case. Even those who are not financially wealthy can easily support a cause they care about without negatively impacting their heirs. In fact, in many cases, the planned gift is a benefit to heirs, allowing them to avoid taxes that would diminish or even negate the gift that is left behind.

There are many ways to do planned giving but for most of us, the very simple ways are the best! Here are the three ways to support North St. Louis County Habitat for Humanity with a Planned Gift:

- I. **Bequests** are the cornerstone of most estate plans and among the easiest ways for you to arrange a gift. You set up a bequest when you include a donation to a cause you care about in your will. Your heirs will pay no taxes on any portion of your estate bequeathed to a charitable organization such as North St. Louis County Habitat for Humanity.
- 2. **Life insurance** is often an overlooked tool for making a Planned Gift. A gift can be set up by selecting NSLCHFH as a beneficiary of all or a portion of the policy's proceeds.
- 3. If you have a **retirement plan**, either through your employer or your own IRA, 401(k), 403(b) or pension plan, You can select NSLCHFH as a beneficiary of all or part the remaining balance.

These are the three easiest ways to support NSLCHFH, without impacting your current income while also helping your heirs avoid high taxes. I would be happy to help you join our "legacy society" or give you more information on these and other Planned Giving options.

Here at Habitat, we are all about building homes, communities and hope! Our homeownership program offers a family, in need of an affordable home the opportunity to build their home with us. This home impacts the family and the community in ways that can last a lifetime. The Research Division of the National Association of Realtors® found that, "homeownership boosts the educational performance of children, induces higher participation in civic and volunteering activity, improves health care outcomes, lowers crime rates and lessens welfare dependency." The benefits for owning a home reach far and wide.

We are accepting applications for the 2018 and 2019 build seasons. Do you know of a family that would benefit from Habitat's homeownership program? As we get to know our partner families, we often hear how they were encouraged to apply by family, friends or co-workers. We often hear stories of applications being requested but not completed or turned in. One family hung on to their application for THREE years! Applying for our program is a big step and encouragement from you may be all that a family needs. I have included our family selection flyer in this newsletter for you to look over and share with a friend, co-worker or family member. By giving someone a flyer, you could be the catalyst for a family celebrating Christmas in their own affordable home next year!

When looking for partner families, we consider three requirements: Need, Ability to Pay and Willingness to Partner.

- **Need:** What is their current living situation? Is it overcrowded? Are their heating costs high? Is the structure unsafe?
- **Ability to Pay:** Do they have a steady source of income (total income not to exceed 60% of the median income for North St, Louis County)? Is their debt manageable? Do they have responsible credit?
- **Willingness to Partner:** Are they willing to build their home? Are they willing to volunteer to build other partner families' homes? Are they willing to attend homeownership classes?

T'were the Days Before Christmas: A Construction Carol

T'were the days before Christmas and the Habitat staff was a flutter, a Habitat home needed its roof, siding and shutter! Ok, we will admit that we are no Clement Clarke Moore but this gives us a great opportunity to tell you how a Habitat home is built. Several weeks ago when winter was getting ready to strike in earnest, the Kniefel home in Mt. Iron still had no roof. Of course we were all concerned and were "a flutter" wondering how we could get the exterior of this home complete before the northland's typical blanket of snow and 40 below zero temps arrived.

Our great partners at the Mesabi Range College's Carpentry Class had some extra days available. They agreed to put their warm clothes on and installed the trusses and sheeting on the roof. A tarp was laid over the plywood to keep the ice off. Meanwhile, Susan Garrett, Steve Burgess, Marnie Maki and Nathan Thompson (our Habitat staff) put their efforts together to find solutions for shingles, soffit, house wrap and siding. A Saturday on the calendar was identified as a great target date, an email was sent out, not early but late! Our great volunteers from near and from far responded. That Saturday we had several of our partner families, an engineering club, Youth for Christ staff, two board members, two of our staff, a warm coffee'an and a great lunch that all came together to work with temps in the twenties. Fortune would have it that two of the volunteers were professional roofers! Several others were sent to the roof to hand shingles while others installed the house wrap on the walls with no windows. The next week, the windows were neatly installed followed by Karen Kniefel's friends and family on the following Saturday who put up the soffit and fascia.

The home was now weather tight but not yet complete so a group of 17 AmeriCorps volunteers from Twin Cities Habitat for Humanity were sweet and came up to the Range to install the siding. From the single digit temps there were none of them hiding! The group was housed by United in Christ Lutheran Church and fed by the Catholic Daughters of Eveleth and Messiah Lutheran Church.

This is a perfect example of the miracles that happen to get a home built with volunteers, donations and God's blessing. This year five new homes are being built and one home is getting rehabbed to help a total of six families into a safe, warm home. It is truly a miracle to see how our great Iron Range community comes together to build homes with our neighbors in need. Thank you!

We still have five of our homes in various stages of completion. There is heat available in them now so come on out and have some fun, we take all skill levels!!



Home: A Door of Opportunity for the Next Generation

One of the best things you do by supporting Habitat, is to help parents build safe, warm and healthy homes for their kids! Our partner families, concerned about their children, have given the following reasons why owning a home is so important to them:

- "Our children will have a yard and more room to play."
- "We will now have a house our children can grow up in."
- "We are giving our children a suitable, stable, safe, secure and healthy home."
- "Our children can stay in the same school and develop relationships."
- "We are setting a good example for our children."
- "Our children will always have a place to come home to no matter their age."

Habitat Minnesota, in partnership with Wilder Research, conducted a survey of Minnesota Habitat homeowners and found that 90% said they feel better about their children's future stating, "Watching the community come together to build our home-helped us as a family realize that we are important, and having a house to live in gives you hope. It helps our self-esteem and gives you hope for the future." About 80% feel they and their children are safer. 64% feel their children's study habits improved after moving into their Habitat home.

You are opening the door of opportunity for the next generation when you build a home. Your generous time, talent and treasure is giving more children the opportunity to build strength, stability and self-reliance in a home that will help form their character and memories for a lifetime.
