The impact of a life well lived

The whole Habitat network was deeply saddened by President Jimmy Carter's passing on December 29. The last few weeks have been a time to reflect on and celebrate his life of service to our country and the world.

President and Rosalynn Carter's work with Habitat for Humanity began in 1984 in Georgia, followed soon in New York City with the first Carter Work Project. To give you a bit of perspective on how many years of dedicated service that is, I was a sophomore in high school at that time! It wasn't long after that when I started to hear about Habitat for Humanity in the news as the organization began to grow in its worldwide impact.

Since 1984, the Jimmy and Rosalynn Carter Work Project has touched lives around the world by inspiring more than 108,000 volunteers to help build, renovate, and repair 4,447 homes in 14 countries. Although they were not the founders of the Habitat organization, the Carters certainly inspired people to join in the work across the world, including here on the Iron Range.

In 1994, a small group of community-minded volunteers saw the plight of their neighbors struggling to find affordable housing. They reached out to Habitat International to inquire about starting their own Habitat affiliate. In April 1995, North St. Louis County Habitat for Humanity was incorporated, and an all-volunteer organization began building its first home in 1996 in West Eveleth.

It is hard to imagine the impact that your actions will have on this world in 30 to 40 years when you wake up in the morning and choose to help your neighbor in need. For President and Mrs. Carter, that impact is thousands served with homeownership across the world. For our founding board members 30 years ago, it is a total of 122 families across 15 of our Iron Range communities—400 people living in safe, energy efficient, and affordable homes.

As we celebrate North St. Louis County Habitat for Humanity's 30th anniversary this year, the Carters' example and the example of our founding board members should inspire us to a life well lived. As we make

today's choices to serve our neighbors in need through our support of Habitat's ministry, what will be the impact in the next 30 years? How many families will we have served? How many children's lives will be impacted by growing up in a safe and warm home? How many more will we inspire to serve others?

I am sure that when President Carter entered the gates of Heaven, he heard the Lord say, "Well done, thou good and faithful servant." His life well lived has inspired a world. He has inspired us here on the Iron Range to love our neighbors and work towards a world where everyone has a decent place to live.

What do we do in winter?

Here at Habitat, "What do you do during the winter?" is one of our most frequently asked questions from volunteers and community members.

The answer is simple—we build houses! We try to line up our building schedule so that our houses are fully dried in and protected from weather and to have at least some form of heat before the weather turns cold and snowy. This helps our subcontractors work safely and effectively as they insulate and install drywall, and it gives volunteers a warm, dry place to work or take breaks if we are working outside.

In the heart of the winter months, we focus primarily on interior finishes. Once the house is insulated, we can install our permanent heating system, and from there our subcontractors tape the drywall and then hand the home back over to us. Through a mix of partner family sweat equity hours and volunteer work, we usually spend January through March painting, flooring, and installing cabinets, doors, millwork and fixtures. Once the weather has changed for the warmer, we are excited to get back outdoors and work on exterior projects like siding, sidewalks, and landscaping.



Our crew of regular Wednesday volunteers dressed for the weather last month and still enjoyed adding siding to the Drake home in Buhl. There are interior and exterior volunteer opportunities year-round!

We might not be framing houses al fresco in January, but we stay plenty busy year-round at Habitat. This season, we have volunteer opportunities in Buhl, Virginia, Tower and Hibbing. We would love to have you join us in the field!

Remembering President Jimmy Carter

Jimmy Carter (1924-2024) served as the United States' 39th president from 1977 to 1981. In March 1984, and former First Lady Rosalynn Carter (1927-2023) worked with Habitat in Americus, Georgia, near President Carter's hometown, Plains. They quickly realized that Habitat's mission closely aligned with their values, and a partnership was formed. Just a few months later, in September of that same year, the Carters led a Habitat for Humanity work group to New York, serving 19 families in need of safe, affordable housing.

The Carters personally hosted Habitat for Humanity's Jimmy & Rosalynn Carter Work Project through 2019, then continued their support of Habitat for Humanity's mission through advocacy. The Twin Cities hosted the 2010 and 2024 Carter Work Projects, and the next project will take place in Austin, Texas in October 2025.

President and Mrs. Carter have been referred to by many as Habitat for Humanity's most famous volunteers during the 35 years they helped build decent and affordable housing with the organization. The Carters lent a hand to Habitat for Humanity as a young, fledging organization and created broad awareness of its work and of its mission. Their efforts helped raise awareness of the critical need for decent and affordable housing in the U.S. and around the world.

In 2016, President and Mrs. Carter were named inaugural Habitat Humanitarians in recognition of their extraordinary dedication to service in alignment with Habitat's vision of a world where everyone has a decent place to live. Habitat Humanitarians are a group of volunteers who also serve as tireless champions, advocates and spokespeople to raise awareness of the need for decent, affordable shelter in the U.S. and around the world.

Habitat is seeking families for 2025 and 2026!

Are you or someone you know in need of affordable housing? Are you tired of renting? Is it your hope to own your own home? Homeownership may be within reach with Habitat! We partner with individuals and families to build simple, decent, and affordable homes in North St. Louis County.

To be accepted into the homeownership program, applicants complete an application and provide supporting documents such as paystubs, tax forms, etc. When reviewing applications, we are looking to see if families meet the following criteria:

Need for housing

Does your current home need many repairs? Do you have high heating costs? Is it overcrowded? Are you unable to secure conventional financing? Is your rent increasing faster than your income? Answering yes to one or more of these questions shows a need for housing.

Ability to pay

When a home is 100% complete, the individual or family will purchase it from Habitat for Humanity with an affordable mortgage. We must ensure that families have the income to support that purchase, along with a history of manageable debt and responsible credit practices. Therefore, we calculate income using guidelines from St. Louis County and run credit reports. Current income guidelines can be found on our website at www.nslchfh.org/homeownership/how-to-apply.

Willingness to partner

Are you willing to help us build your home? The homes of others? Attend homebuyer educational meetings? The key word here is willing. It is not about your ability to build a home, but your willingness to participate in the process. Come raise walls with us!



Other requirements

Applicants must live and/or work in North St. Louis County for at least six months prior to applying, be a U.S. Citizen or legal resident, and have a stable source of income of at least \$30,000. (The minimum income requirement may be more depending on family size, debt to income ratio, source of income, etc.)

Next steps

If you feel you meet the above criteria and requirements or have questions, call me at 218-749-8910. I would love to visit with you about how we can partner to build a home with you! It will take you to the Homeownership – How to Apply section where you can complete the Applicant Inquiry form at the bottom of the page.



Acceptance in the program—now what?

Expect to jump right in and start working towards your sweat equity goals! Each adult in the household is required to complete a minimum of 200 hours and recruit a minimum of 100 hours from friends and family.

Add the first Monday of the month to your calendar to attend our required Partner Family Meeting, where we cover educational topics. Topics include "What to Expect at Closing," "How to be a Good Neighbor," and "Financial Literacy Basics." The goal is providing families with information that sets them up for successful homeownership. We often invite community members to share their expertise. For example, it is so beneficial to have a fire marshal talk about fire safety and the police chief talk about being a good neighbor and how best to stay safe at home.
